# Board of Governors Meeting December 12, 2012

#### **Board of Governors**

#### **AAMC 2012-13 Goals**

Marge Nicholson and I reviewed the ideas that came out of our brainstorming during the March 2012 board retreat. These ideas supported the 6 major goals that the board has been working towards since 2008. Marge and I determined what we thought were the most important and doable ideas to help build a stronger organization this year and put us in the best position for the future. The Executive committee reviewed the list, made some suggestions and approved these goals for the remainder of this fiscal year (see accompanying document).

#### **Bylaws**

I chaired a meeting of the Bylaws committee in November. The committee had met previously in the spring of 2012 under the leadership of Lucy Do and had developed a list of revisions to the bylaws. The committee reviewed the suggestions in November and a revised document is ready to be presented to the Board of Governors.

## **AAMC Collection of Mills jewelry**

I have asked Mills alumna Jesse Wilson to inventory and catalog the AAMC's collection of Mills jewelry. In addition to Pearl M pins, alumnae have donated other rings, necklaces, and pins they received as students or alumnae. Jesse has extensive experience cataloging collections of museums here and abroad. We have also brainstormed ways to exhibit the collection such as an online exhibit or organizing an exhibit for reunion.
