#### II. PRESIDENT'S REMARKS

#### Alecia DeCoudreaux

- A. Thanked all alumnae volunteers especially the Reunion Committee and Guevara, Jaquez-Fissori, Faletti, Campfield, and Nicholson for all the events they helped to organize at Reunion 2011.
- B. Wants to strengthen the ties between the Alumnae Association and The College.
  - a. Was a volunteer and has been a member of the Board of Trustees at Wellesley College for 10 years. She appreciates the work our volunteers do on behalf of Mills College and understands the importance of this work.
- C. This is a time of transition for The College and the Board of Trustees.
  - a. Spending a lot of time thinking about how we're structured.
  - b. Focusing on enrollment management and established an enrollment task force.

- c. Facing budget shortfall and the Board of Trustees is addressing this.
- d. The Chair of the Board of Trustees is ensuring that we have the best governance practices in place.
- e. President DeCoudreaux will attend future Board of Governors meetings and keep us posted on upcoming changes and would like feedback from us.

#### A. Reunion 2011

## B. Plan to introduce President DeCoudreaux

- a. It's a five-part plan. See report.
- b. Will travel to Chicago next Friday. This is a pilot visit. President DeCoudreaux will have discussions with alumnae and talk about what is special about Mills.
- c. Making sure to have dialogue between alumnae and The College.
- d. Focusing on California events. We will have 10 events in the areas of California where we have the most alumnae and 10 events outside of California.
- e. Planning events around President DeCoudreaux's schedule. Lots of coordination.
- f. Visiting donors, alumnae branches, and corporate donors.
- g. **ACTION ITEM:** Will bring President DeCoudreaux's itinerary to December's meeting.

#### C. Alumnae Relations Advisory Committee (ARAC)

- a. Hoping to regroup in early November and set goals for 2012.
- b. Will discuss how its work could serve to introduce President DeCoudreaux and how it would help to forge a stronger partnership between the Board of Governors and The College.

c. Results from the quantitative survey are 100 pages long. Jaquez-Fissori has a binder with all the survey results. Lots of statistical data. Had over 800 responses to the survey.

## V. PRESIDENT'S REPORT

## Linda Jaquez-Fissori

- A. 81% of the BOG made a gift to the AAMC in fiscal year 2010-2011.
- B. During reunion, we sold \$2,275 of merchandise. \$600 is going back to the Orange County Branch, since we sold some of their merchandise.
- C. Continuing to do administrative work in the office. Leslie MacNeil is helping with some of the administrative work, but needs more volunteer help during the week.

### D. ACTION ITEMS:

- a. Looking for more volunteer help in the office.
- b. Needs to understand how everything will work with regard to the possibility of hiring a work-study student and how we would budget for it.

#### VI. FINANCE COMMITTEE

## Karlin Sorenson

- A. We currently do not have a manual on how our books were kept. Has been coming into the office on weekends to clean up and organize them.
- B. The budget for 2010-2011 was \$57,619 and we were \$800 over budget. Since we eliminated paid staffing, we will most likely not need to take money from the Admin Fund.
  - a. Finance Committee proposed to leave budget as is for now.
  - b. Looking for ways to save money. Have cut phone lines that are no longer needed.
- C. Mark Curtis joined the Finance Committee. Curtis manages investment accounts.
- D. AAMC Endowment Fund.
  - a. Might put the fund into an Index Fund.
  - b. Gifts to this fund for 2010-2011: \$20,331.
  - c. Drop in gifts since last year.

#### **E. ACTION ITEMS:**

- a. Need to educate alumnae about giving to the AAMC Endowment Fund, in addition to The College. Might need to create a "script" so we can explain what is needed.
- b. Will have conversation about fundraising at our next meeting.
- c. Line items on our budget are old. Will need to change them.

  - a. 275 people attended. President DeCoudreaux and her mother attended.
