### II. PRESIDENT'S REPORT

# Alecia DeCoudreaux

- A. Thanked Ketelle, Nicholson, Jaquez-Fissori, and Do for being present at the candle-lighting ceremony for the transfer students.
- B. While attending meetings with national boards and meeting with other college presidents, she had the opportunity to visit with alumnae in New York and Boston. Both events were well-attended but the groups were smaller than expected. Will have two more events in the Bay Area very soon. She will ask alumnae at these events how they would like to participate in the future of Mills.
  - a. March 3<sup>rd</sup>: Walnut Creek
  - b. April 1st: Oakland

- C. Wants to grow Alumnae Admission Representative Program and get more people involved with the AAMC Board of Governors. The success of Alumnae Relations programming depends on alumnae willingness to engage. Wants to encourage alumnae to run for BOG or Trustee positions.
- D. Board of Trustees meetings started today. The focus is on enrollment management and the budget. Identified \$3.2 million that will help us through the year. Trying to find \$4.6 million total. Looking at expense reductions and how to increase revenue. Last year, tuition was raised 4.5%, but had lower enrollment as a result of that increase. Trying to calculate what it costs to come to Mills and to make it easier to afford. Made some budget cuts, but does not want to cut more. There will be no further cuts to staff.
- E. Will start search for new Dean of Students ASAP.
- F. Board of Trustees had Student Affairs Committee meeting today. Met with Tamayo and other members of the ASMC. The ASMC has worked with the Provost's Office to bring "Latin Honors" to Mills. Tamayo raised the issue about grade inflation at Mills.

- B. Between July and November of 2011, we had 78% giving participation from the board for the AAMC Endowment Fund. We still don't have numbers from December yet. 25 people gave \$6,000. Average gift was \$181.00.
- C. The tickets that we sold for Educational Outreach events are not considered income, since we are getting money back for what we spent on pre-bought tickets.
- D. Gift reports we get from the College are delayed. As a result, acknowledgements to donors are sent two months later than usual.
